#### What is the purpose of this update?

#### Description of this fund

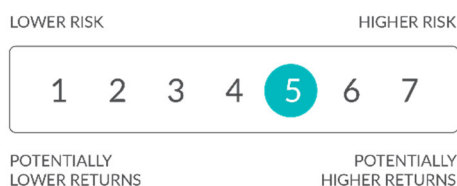
The Global Equities Fund invests in international shares. It aims to achieve long-term returns (before fees, taxes and other expenses) greater than the MSCI ACWI Net Total Return Index, 50% hedged to the New Zealand dollar.

#### What are the risks of investing?

Risk indicator for the Global Equities Fund:

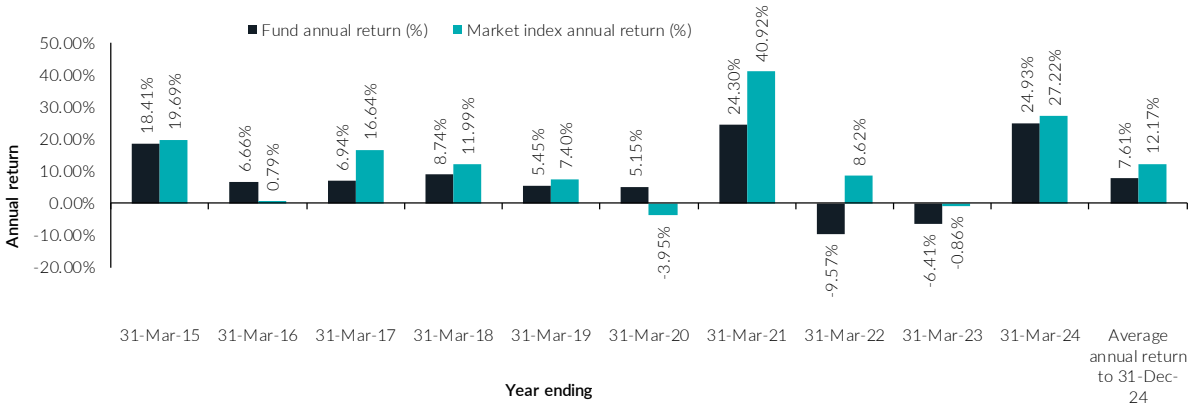

#### How has the fund performed?

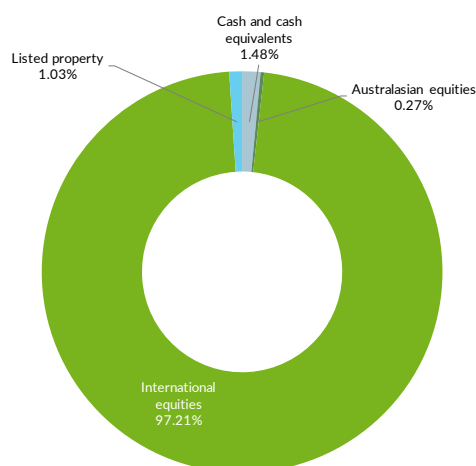
### Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$1,844 (that is 18.44% of her initial \$10,000). This gives Jane a total return after tax of \$1,897 for the year.

The top 10 investments make up 49.50% of the fund.

We actively manage the fund's foreign currency exposures. As at 31 December 2024, these exposures represented 99.14% of the value of the fund. After allowing for foreign currency hedges in place, 35.76% of the value of the fund was unhedged and exposed to foreign currency risk.
