What is the purpose of this update?

Description of this fund

The Forsyth Barr Global Equities Fund invests in selected international shares. We aim for positive long-term returns. These kinds of investments will typically have high levels of movement up and down in value.

What are the risks of investing?

Risk indicator for Forsyth Barr Global Equities Fund:




Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane incurred a loss after fund charges were deducted but before tax of \$791 (that is -7.91% of her initial \$10,000). This gives Jane a total loss after tax of \$864 for the year.

The top 10 investments make up 42.11% of the fund.

We actively manage the fund's foreign currency exposures. As at 31 December 2018, these exposures represented 92.14% of the value of the fund; the remainder of the fund was invested as New Zealand dollar cash. After allowing for foreign currency hedges in place, 83.22% of the value of the fund was unhedged and exposed to foreign currency risk.
