#### What is the purpose of this update?


# Description of this fund

The fund aims to achieve positive long-term returns by selecting a lesser exposure to cash and fixed interest investments and a greater exposure to equity and property investments. Investors can expect high levels of movement up and down in value and to receive longer-term returns that are higher than those of the Balanced Fund (but with more risk).

### What are the risks of investing?

Risk indicator<sup>2</sup> for Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



# How has the fund performed?

The index used to measure the performance of the New Zealand Fixed Interest asset class has changed since the last fund update due to a decision by the investment manager that the new index was more appropriate in terms of assessing movements in the market in relation to the returns from the assets in that sector. This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2023.

Small differences in fees and charges can have a big impact on your investment over the long term.


#### Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$1,235 (that is 12.35% of her initial \$10,000). This gives Jane a total return after tax of \$1,119 for the year.

The top 10 investments make up 31.05% of the fund.

Foreign currency exposures associated with international fixed interest are hedged to the New Zealand dollar. We actively manage the fund's foreign currency exposures associated with international and Australian equities, and listed property. As at 31 December 2023, these exposures represented 52.14% of the value of the fund. After allowing for foreign currency hedges in place, 26.98% of the value of the fund was unhedged and exposed to foreign currency risk.
