# Australian Equities Fund Octagon Investment Funds Fund Update as at 30 June 2023

What is the purpose of this update?

This document tells you how the Australian Equities Fund<sup>1</sup> has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# Description of this fund

The Australian Equities Fund invests mostly in selected Australian shares, and in New Zealand listed shares, where the company has meaningful operations in Australia, and aims to achieve positive long-term returns. These kinds of investments will typically have very high levels of movement up and down in value.

### What are the risks of investing?


Investors are not currently charged any other fees. See the PDS for more information about fees. Small differences in fees and charges can have a big impact on your investment over the long term.

#### Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$1,444 (that is 14.44% of her initial \$10,000). This gives Jane a total return after tax of \$1,284 for the year.

The top 10 investments make up 44.13% of the fund.

We actively manage the fund's foreign currency exposures. As at 30 June 2023, these exposures represented 99.71% of the value of the fund. After allowing for foreign currency hedges in place, 63.01% of the value of the fund was unhedged and exposed to foreign currency risk.
