
Description of this fund

The fund aims to provide a return above the Official Cash Rate (OCR) over a rolling 12 month period, by investing in cash, cash equivalents and short-term New Zealand fixed interest assets. These investments typically have very low movement up and down in value.

What are the risks of investing?

Risk indicator¹ for the Enhanced Cash Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


Example of how this applies to an investor³

Jane had \$10,000 in the fund since its inception on 7 June 2023 and did not make any further contributions. At the end of June 2023, Jane received a return after fund charges were deducted but before tax of \$33 (that is 0.33% of her initial \$10,000). This gives Jane a total return after tax of \$24 for the period.
