What is the purpose of this update?

Description of this fund

The Forsyth Barr Global Equities Fund invests in selected international shares. We aim for positive long-term returns. These kinds of investments will typically have very high levels of movement up and down in value.

What are the risks of investing?




Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$636 (that is 6.36% of her initial \$10,000). This gives Jane a total return after tax of \$545 for the year.

The top 10 investments make up 38.01% of the fund.

We actively manage the fund's foreign currency exposures. As at 31 March 2019, these exposures represented 97.74% of the value of the fund; the remainder of the fund was invested as New Zealand dollar cash. After allowing for foreign currency hedges in place, 82.68% of the value of the fund was unhedged and exposed to foreign currency risk.
