What is the purpose of this update?

This document tells you how the Forsyth Barr NZ Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Forsyth Barr NZ Fixed Interest Fund invests in selected New Zealand fixed interest assets. We aim for positive longterm returns. These kinds of investments will typically have low levels of movement up and down in value.

What are the risks of investing?

Risk indicator for Forsyth Barr NZ Fixed Interest Fund:




