# Octagon Investment Funds Fund Update as at 30 September 2023

This fund update was first made publicly available on 27 October 2023.

#### What is the purpose of this update?

This document tells you how the Enhanced Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The fund aims to provide a return above the Official Cash Rate (OCR) over a rolling 12 month period, by investing in cash, cash equivalents and short-term New Zealand fixed interest assets. These investments typically have very low movement up and down in value.

#### What are the risks of investing?


#### Example of how this applies to an investor<sup>3</sup>

Jane had \$10,000 in the fund since its inception on 7 June 2023 and did not make any further contributions. At the end of September 2023, Jane received a return after fund charges were deducted but before tax of \$169 (that is 1.69% of her initial \$10,000). This gives Jane a total return after tax of \$122 for the period.
